Abstract submission conditions

Abstracts must be submitted no later than 21 May 2025

- Abstracts must be submitted in English.
- Abstracts will be reviewed and selected for oral presentations.
 Abstracts that are not selected for oral presentation will have the opportunity to be included in the official online abstract overview.
- The final selection of oral presentations is subject to the Scientific Committee's discretion.
- Accepted abstracts will be published in the Symposium's abstract overview on the website.
- Submission of an abstract grants EFOA 2025 the right to publish the abstract in on the symposium website.
- Withdrawal of abstracts can only be accepted if notified in writing and subsequently confirmed by the EFOA 2025 Symposium Secretariat.

Content of your abstract

- The abstract should state briefly and clearly the purpose, methods, results, and conclusions of the work.
- The main body of the abstract is limited to 250 words maximum (main text, excluding title, author names and affiliations, as well as funding information and references, if any).
 - You will be asked to enter the title, name(s) of author(s) and their affiliation(s) when you submit your abstract in the system.

Abstracts presenters

• The presenting author must register as an active participant at the EFOA 2025 Symposium at the latest <u>14 days after acceptance</u> notification of an abstract. Please be aware of the deadline for early bird tickets (1 June), if you want to take advantage of this offer.



Enteric Fistula and Open Abdomen

- The EFOA 2025 Symposium Secretariat reserves the right to exclude any abstract that is not followed by a participant registration at the latest 14 days after notification of acceptance.
- You are allowed to submit one abstract as the registered author, but can be a co-author on multiple abstracts.
- Abstract presenters will be **required** to attend EFOA 2025 in-person to make their <u>presentation</u>. Expenses associated with an abstract presentation (e.g., travel, hotel, congress registration fees, etc.) are the sole responsibility of the presenting author.

Review and notifications

- The scientific committee will review the abstracts.
- Notification of acceptance or rejection of the abstract will be sent to submitters by 26 May 2025.
- It is the responsibility of all investigators that all studies are performed with respect to national legislation, international legislation and ethical guidelines both with regards to humans and/or animals. The EFOA 2025 Scientific Committee reserves the right to reject any submitted abstract that is believed to violate these principles.
- Please verify that your email address (submitter and presenting author) is correct, as it will be used for contacting you after the review process.
